### **Notes**

#### **Constitutional Conventions: Supports study of Constitutional Law I**

**Insurance Law:** The course is highly discussion interactive and will provide an in-depth study of insurance law including: the role of insurance in society, types of insuring agreements and contracts, definitions, government oversight and state-based regulation, insurance fraud nationally and globally, the covenant of good faith and fair dealing, use of particular clauses and endorsements to control risks, and the rise of AI and other technology in the insurance marketplace. Students will also be exposed to the myriads of insurance-related career opportunities for attorneys. Grading is based 20% on class participation; there will be the opportunity for individual or group class work projects for 20% of the grade; and the remaining 60% of the class grade will be based on the final exam.

**Lunsford Seminar II:** Will not follow a weekly class schedule. Class sessions will be announced in advance of the beginning of the course.

**Witness Preparation:** Will meet five Saturdays throughout the semester

**Antitrust Law:** This course will provide an overview of antitrust law, focusing on fundamentals and modern issues with a practical application to an in-house setting or for an in-house corporate attorney with a desire to understand the basics of antitrust. By the end of this course, you should have a basic understanding of fundamental antitrust principles and concepts that are appropriate for a corporate setting or law firm counseling corporate clients. Instructor [Katherine Bakker](#) is the Group Antitrust Practice Senior Director and Associate General Counsel at Procter & Gamble having previously served as the P&G Antitrust Senior Legal Counsel for North America.

**The Business of IP:** The course will be a survey and analysis of intellectual property rights (especially patents) as they impact “real world” business systems with an emphasis on broader public and economic policy considerations. Students will explore the practice and theory of patent and other IP rights as they influence business plans and operations, and their impact on the broader economy and society. Discussions will focus on the balancing of the interest and rights of IP holders, competitors, and the public while exploring how the intended incentives, balances, and rights, can be optimized or abused in socially relevant and familiar examples. Instructor [Matthew Fitzpatrick](#) is recently retired Vice President & Associate General Counsel at Procter & Gamble and formerly responsible for P&G Global Health Care business including managing the legal divisions in North America, Asia, and Europe.
